ORDER NO. FD 61 SRP 82(II), DATED, BANGALORE THE 10TH JUNE 1983.

Fixed Travelling Allowance had been sanctioned in some cases and was continued from time to time. The question of revising the rates of this allowance has been examined by Government.

2. Government are now pleased to revise the rates of fixed Travelling Allowance with effect from 1st June 1983 as follows:

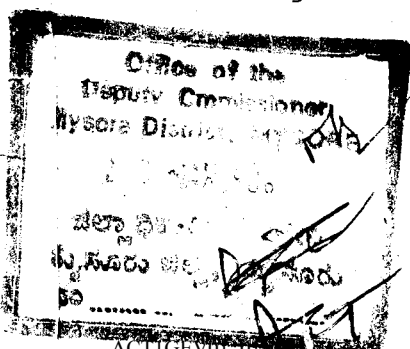

3. The revised rates of Fixed Travelling Allowance shall be admissible for a period of two years from 1.6.1983 or until further orders whichever is earlier.

4. All the existing cases of Government servants to whom Fixed Travelling Allowance has been sanctioned should be reviewed and proposals for its further continuance beyond 31.5.85 should be sent to Government in Finance Department through the concerned Administrative Department.

5. The existing rates of Fixed Travelling Allowance may be continued in respect of the posts which are not covered by this order. Proposals for revision of the rates of Fixed Travelling Allowance in respect of those posts may be sent to

Government in Finance Department through the Administrative Department alongwith the following particulars :

- (a) Number of posts
- (b) existing rate of allowance
- (c) Nature of work and jurisdiction
- (d) Average number of days touring in a month.
- (e) Number of Government vehicles provided for use of the office/Department.

6. The Officers/Staff who have been provided with Government vehicles for journey on official use will not however be eligible for Fixed Travelling Allowance. The other existing conditions regulating Fixed Travelling Allowance will continue to apply.
