Subject: Continuance of the posts of Gramasahayaks beyond
15-9-1985 - Regarding.

ORDER NO. RD 366 MVS 84, BANGALORE, DATED 20-1-1986.

P r e a m b l e:

By Government Order dated 16-9-1978 read at (1) above 8941 Stipendiary Posts of Gramasahayaks were created on a temporary basis for a period of 5 years. By Government Order dated 23-9-82 read at (2) above, 1509 additional posts of Gramasahayaks were created on temporary basis, co-terminus with the sanctioned period of 8941 posts of Gramasahayaks created in Govt. Order read at (1) above. In all 10,450 posts of Gramasahayaks were created as per the terms and conditions stipulated in the said Govt. Orders and also instructions issued from time to time in this behalf.

By Govt. Order RD 188 MVS(1) 83, dated 3-1-1984 read at (3) above 10,450 Stipendiary posts of Gramasahayaks have been continued for a period of two years from 16-9-1983 in the Districts mentioned in the Annexure to the Government Orders read at (1) and (2) above.

The Divisional Commissioners and Deputy Commissioners while reporting that the currency of the continuance of the posts of Gramasahayaks posts expired on 15-9-1985 have requested for further continuance of these posts as their services are absolutely necessary. The Karnataka State Government 'D' Group Employees Association, Bangalore and various Gramasahayaks Associations have also requested Government for further continuance of Gramasahayaks posts as they are put to hardship on account of non-receipt of remuneration.

O R D E R.

Sanction is accorded for the continuance of 10,450 Stipendiary Posts of Gramasahayaks for a further period of one year from 16-9-1985 in the Districts mentioned in the Annexure to the Government Orders read at (1) and (2) above, subject to the terms and conditions stipulated in the said Government Orders as also instructions issued from time to time in this behalf.

This order issues with the concurrence of Finance Department vide their No. FD 22/Exp-VII/86, dated 17-1-1986.
